At its meeting on June 9, 2010, the California Coastal Commission modified one of the Commission's original suggested modifications to the Dana Point Harbor Revitalization Plan that the City had previously accepted. The City Council will consider whether or not to accept this latest modification to the City's prior approval of the Dana Point Harbor Revitalization Plan.

Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
