

**ORANGE COUNTY TREASURER-TAX COLLECTOR**  
**APPLICATION FOR PROPERTY TAX RELIEF FOR MILITARY PERSONNEL**  
(Pursuant to the Soldiers' and Sailors' Relief Act of 1940)



Military personnel on active duty are eligible to defer the payment of their taxes under the provisions of the Soldiers' and Sailors' Civil Relief Act. Instead of the penalties, costs and fees imposed under California law, the unpaid taxes are subject only to interest at the rate of six percent (6%) per annum (Orange County is waiving the interest provision as well). This application form may be completed by the military serviceperson, his/her adult dependent, or any other individual authorized by the service person to act on his/her behalf. Please complete the information below and file the form with the Tax-Collector of the county in which the property is located.
